Statement of Responsibility and Release

In consideration of participating in events at the Berlin Yacht Club, I agree that I will be responsible for the acts and omissions of myself, my crew and my guests. I understand and appreciate the risks of sailboat racing and its potential for accident, injury, and death, and I will make certain that my crew and my guests also appreciate such risks. I agree that it is my sole responsibility to make an informed decision whether I, my crew and guests should participate in a given event and the safety precautions we should take, giving consideration to my independent analysis of weather, wind and waves that will, or may be encountered during the event. I, for myself, my crew and guests and the heirs, successors and assigns of any of them, do hereby waive, release and forever discharge Berlin Yacht Club, its officers, trustees, race committees, agents and representatives (collectively BYC) from any and all loss, cost, damage or expense (collectively `loss') arising out of, or resulting from directly or indirectly, my participation or the participation of my crew or guests in, at or around a BYC event, and whether or not the loss is claimed to be caused in whole or in part by the negligent acts or omissions of BYC. I further agree on behalf of myself, my heirs, successors and assigns, to indemnify and hold absolutely harmless BYC for any claims, demands or suits that are made against BYC based on the acts or omissions of, or damages or injuries to myself, my crew and my guests, or based on a claim that some or all of this Statement of Responsibility is not valid and binding, and regardless of who may be the claimant and whether or not BYC is claimed to be somehow liable therefore. I further certify that I am an adult and I am signing this form on my own behalf or on behalf of my minor child. In the event I am the parent or guardian of a minor or minors participating in an event at the BYC, I additionally make the preceding commitments on behalf of such minor or minors as well as myself.
